## Characteristics

- Dermatologically tested

- No colourings, aromatic substances or other additives
- Extremely short application time

## Areas of application

Ready-for-use alcoholic disinfectant for the hygienic and surgical washing of hands, to combat harmful organisms, dermatologically tested.

## Application

For hygienic hand disinfection, rub the hands with 3ml of the solution and keep them moist for the application time stated below. For hygienic hand disinfection, rub the hands and forearms with the solution and keep them moist for the application times stated below. For cold poultices, the solutions is to be applied diluted with an equal amount of water.

Conc. 30 sec.

Surgical hand disinfection as per EN 12791, VAH:

Conc. 1min.

TbB (*M. terrae*) as per EN 14348 (dirty conditions):

Conc. 30 sec.

Enveloped viruses (e.g. HBV, HIV and HCV) as per RKI/DVV and EN 14476 (dirty conditions):

Conc. 15 sec.

Noroviruses as per EN 14476, (dirty conditions):

Conc. 30 sec.

## Safety guidelines
