Characteristics

- Perfectly combines washing and decontaminating in one product
- (Rinse off with water)
- Skin-friendly pH value, alcohol-free, no PHMB
- The hands do not dry out even after frequent washing

Product type

Bactericidal wash lotion skin-friendly pH value and skin care effect.

Areas of application

Hygienic wash lotion as per EN 1499 for application to the hands and skin. The product cleans and decontaminates in one working stage.

Notes on application

Wash lotion SCRUB gently cleans and decontaminates in one go and breaks the chain of infection. Due to the physiological pH value, the product has very good skin tolerance, with allantoin and without colourings or aromatic substances. For use in the medical and food-processing industry.

Moisten the hands with water, apply approx. 3 ml of wash lotion to the hands, allow to foam for at least 30 seconds, and then rinse thoroughly with water.

Also suitable for temporary washing of the whole body in the event of MRSA contamination. To do so, apply the product to a damp cloth or sponge and use it to wipe the skin. After at least 30 seconds rinse the affected area of skin with water. When showering, the wash lotion is to be used like commercially-available products.

1.2g chlorhexidine gluconate

0.98g didecyldimethylammonium chloride

Application times

Bactericidal (incl. MRSA) and levurocidal (candida albicans) as per EN 13727, EN 13624 (dirty conditions):

Conc. 30 sec.

Hygienic hand wash as per EN 1499 and VAH:

Conc. 30 sec.
