0.24g C12-14alkyl[(ethylphenyl)methyl]dimethyl ammonium chloride

fully covered by the solution.Immerse alginates and hydrocolloids for a short time only and let them dry. Then rinse the impression with water. Do not mix with cleaning agents or other disinfectants. Depending on the degree of contamination, the working solution may need to be replaced (RKI recommendation: at least once per working day). The working solution can also be disposed of in the sewage water system.

Noroviruses as per EN 14476, (clean conditions):

Conc. 30 min.

Rotaviruses as per BGA/DVV, (clean conditions):

Conc. 1 min.
